
Index of Industrial Production (IIP) is of immense use for measuring the industrial development of a state. The index indicates relative change over the time in the volume of production in non-agricultural commodities. At the national level, the IIP is being compiled by the National Statistical Office (NSO),

# **NEWS:**

Quick Estimate of Index of Industrial Production Month of June, 2025 (Base Year 2011-12=100)

Government of India and is released on monthly basis. The Directorate of Economics and Statistics has been compiling/releasing IIP for the State of Rajasthan on monthly and annually basis.

Three major industrial sectors namely (i) **Manufacturing** (ii) **Mining** and **Quarrying** and (iii) **Electricity** were considered for the purpose of compilation of state IIP. The proportions of value of output for these sectors were converted in to sector **weights**, such that their total equals to 1000.



Base year of IIP in Rajasthan and India is 2011-12. Out of the three sectors, mining and electricity are in the form of a composite index. For preparation of IIP for Rajasthan, initially for manufacturing sector **314** industrial units have been selected for collection of production data in respect of **15**6 items. For mining sector, the information of **13** items provided by the Indian Bureau of Mines (IBM) to the state and the electricity generation figures (single item) are obtained from the Central Electricity Authority (CEA) website.


## 1. Indices:

For the month of June, 2025, the quick estimates of IIP with base year 2011-12 stands at 148.96 against 158.07 in June, 2024. The indices of industrial production for the manufacturing, mining and electricity sectors for the month of June, 2025 stand at 173.79, 89.68 and 158.36 respectively.

## 2. Growth Rate (Y-o-Y):

The IIP growth rate for the month of June, 2025 over the corresponding period of previous year is -5.76 percent. The IIP growth rate in June, 2024 was 2.11 percent. The growth rates of the three sectors manufacturing, mining and electricity for the month of June, 2025 over June, 2024 are -3.02 percent, -8.58 percent and -16.16 percent respectively.



# 4. Comparison of Indices (India & Rajasthan):


