INTRODUCTION

INTRODUCTION

Index of Industrial Production (IIP) is of immense use for measuring the industrial development index of a State. The index indicates relative change over the time in the volume of production in non-agricultural commodities. At the National level, the Index of Industrial Production (IIP) is being compiled by the National Statistical Office, Govt. of India and is released on monthly basis. This index, however, does not serve the purpose for evaluating the industrial growth of a State. Therefore, the Directorate of Economics and Statistics has been compiling/releasing the index of industrial production for the State of Rajasthan on monthly/annual basis since 1971.

In the first series, 1970 was the base year for compiling the IIP both by the Central Statistical Organization & Directorate of Economics and Statistics, Rajasthan a Working Group was constituted under the chairmanship of Dr. Sumitra Chaudhuri, former Member, Planning Commission, for evolving the methodology for compilation of all-India Index of Industrial Production (IIP) with the new base year 2011-12. The report of the Working Group (WG) was submitted to the Government of India in April 2014.

The specifications with regard to the drawing of the item basket and weighting diagram as recommended by the WG have been elucidated below as guidelines for framing the IIP for States/ UTs with base year 2011-12.

The recommendation of the Technical Advisory Committee on comparable Index of Industrial Production (IIP) are examined by the National Statistical Office (CSO), Govt. of India and the guidelines on compilation of State level Index of Industrial Production (IIP) are prepared. According to criteria laid down in the guidelines issued by National Statistical Office, the Directorate of Economic and Statistics Rajasthan selected the items basket and prepared the weighting diagram for preparation of comparable State Level Index of Industrial Production with 2011-12 as base year.

Base year and frequency

Since the base year for all-India IIP in the new series has been revised to 2011-12, it is advisable for the States/ UTs to adopt the same base in order to maintain comparability with the all-India figures as well as inter-state comparability.

The frequency of releasing the IIP should preferably be monthly. If bringing out a monthly IIP is not feasible in the initial stages, a quarterly IIP should be published with extra

efforts being made to sensitize the factories and increase response rates and their frequency in order to shift to a monthly IIP as soon as possible.

METHODOLOGY

1. COVERAGE IN STATE IIP

✦ Three major sectors

- ◆ Mining and Quarrying
- ◆ Registered Manufacturing
- ◆ Electricity

2. SELECTION OF ITEM BASKET FOR MANUFACTURING SECTOR:

2.1 ITEM BASKET

The scope of IIP constitutes the mining, manufacturing and electricity sectors. Out of the three sectors, mining and electricity are in the form of a composite index.

In case of the index for the *Mining sector*, the item basket as well as the weights are decided and provided by the Indian Bureau of Mines (IBM) to the States/ UTs. IBM supplies a composite index in regard to the items prevalent in the mining sector on the basis of data provided by the mines in the respective states.

For the *Electricity sector*, the electricity generation figures (single item) may be obtained by the Central Electricity Authority (CEA).

In case of the *Manufacturing sector*, the basis for selection of item basket is the Gross Value Output (GVO) figures for products from the Annual Survey of Industries (ASI) 2011-12.

It has been noticed that in the production data of ASI, many products correspond with more than one industry groups (NIC 3-digit level) with varying unit values. This seems to be happened due to the practice of classifying NIC of the factory by the major product

manufactured in the factory. It is established that the NIC group in which the product's maximum value occurs is the most correct industrial grouping of the product. Thus for selection of the item basket, a product which gets aligned to more than one NIC groups, has been taken in that particular NIC (3-digit) group in which it has maximum value of output. Thus the methodology proposed for the construction of state-level IIP is as below:

- Using the ASI 2011-12 production data pertaining to NIC 10 to 32 the first job is to remove 'other products and by-products' from all the industry groups after re-distributing their values over the rest of the products occurring in the respective industry groups (NIC 3 digits).
- Subsequently, each product (7-digit NPCMS) is placed in alignment with a particular industry group (NIC 3-digit level) in which the product's maximum GVO occurred, leaving with a unique product description, its NPCMS code, its maximum value occurring over the complete dataset and the industry group pertaining to the maximum value.
- From the list stated above, the product descriptions at the 7-digit level of the NPCMS corresponding to not-elsewhere-classified (n.e.c.) products are removed and the contributions of all such products in a particular industry group are re-distributed among the non-'n.e.c.' products. This is done to avoid ambiguity of description as well as to facilitate easy identification and collection of data pertaining to these items from the factories.
- The list of products thus obtained is arranged in descending order of value of output within each 3-digit level of NIC and then starting from the highest contributor, all the products are to be selected till total value of output of the selected products becomes at least 80% of the total value of output at each 3-digit level.

2.2 WEIGHTING DIAGRAM:

For the purpose of compilation of State IIP, three Major Industrial Sectors namely (i) Manufacturing (ii) Mining and Quarrying and (iii) Electricity (Excluding Gas) were

considered. The proportions of value of output for these sectors were converted in to sector weights, such that their total equals 1000. The value of output figures for the manufacturing sector were taken from the ASI Detailed Results 2011-12 which were supplied by NSO whereas the value of output figures for the Mining and Quarrying and Electricity sectors were supplied by IBM, Nagpur and NSO respectively.

The total weight of the manufacturing sector (Registered and Un-Registered) was apportioned among the 2-digit industry groups in proportion of their value of output available from the detailed results of ASI 2011-12

As regards Mining and Quarrying Sector its weight was apportioned to the items included in the item basket in proportion to their value of output. Since Electricity sector is a single sector, no apportioning of weight is required.

2.3 SELECTION OF FACTORIES:

Once the item basket for a State/UT has been derived, the list of factories under an item may be selected by considering complete list of factories having a substantial combined/aggregate share (at least 25%),¹ of production of the item in the State/UT from ASI 11-12 data. All endeavor should be made to provide a reserve list of factories at item level.

2.4 SOURCE OF DATA:

For preparation of the Current Series (Base Year: 2011-12) of index of Industrial Production, for Rajasthan, initially 314 industrial units have been selected for collection of production data in respect of 156 items. The base year (2011-12) production data in respect of the selected items have been supplied by N.S.O. on the basis of 2011-12 schedules made available by NSSO. The monthly data of the production for the subsequent period i.e. from 2001 onwards is being obtained directly from the Industrial Units. The source of Mining Sector data is the Indian Bureau of Mines, Nagpur and for the Electricity Sector generation figures furnished by the Central Electricity Authority through N.S.O.

2.5 METHOD OF CALCULATION OF IIP:

The monthly Index of Industrial Production is calculated as Weighted Arithmetic Mean of the production relatives in respect of selected items as follows:

$$I = \frac{\sum R_i \times W_i}{\sum W_i}$$

Where I is the index, R_i is the production relative of item i^{th} and W_i is the Weight allotted to it.

The production relative (R_i) of i^{th} item for the month has been calculated by using the following formula:

$$R_i = \frac{P_{ic}}{P_{io}} \times 100$$

Where P_{ic} = Production of i^{th} item in the current month,

P_{io} = Production of the i^{th} item in the base month.

Annual Index of Industrial Production is calculated as arithmetic average of monthly indices.

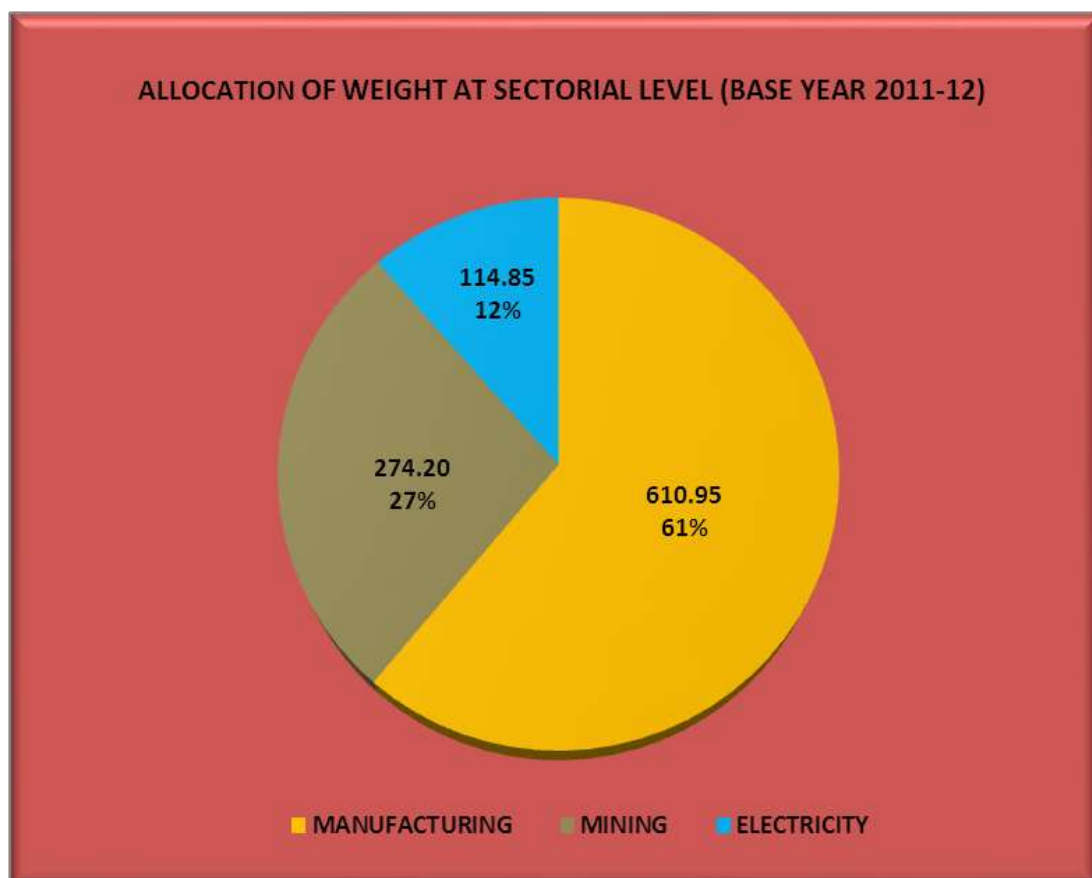

General Review & Growth

GENERAL REVIEW of IIP 2024-25

1. GENERAL PERFORMANCE

The General index of Industrial Production stood at 154.38 during 2024-25 as against 153.46 in 2023-24 there by registering an increase of 0.60 percent. During the year 2024-25 the General Index stood at highest with 166.49 in May, 2024 and in February, 2025 the index was at its lowest with 140.96.

2. MANUFACTURING SECTOR

The Manufacturing sector index stood at 175.21 during 2024-25 with an increase of 3.37 percent when compared to the previous year. During the year 2024-25 the Manufacturing sector Index stood at highest with 192.35 in May, 2024 and in February, 2025 the index was at its lowest with 156.27.

3. MINING SECTOR

The Mining sector index stood at 97.30 during 2024-25 with an decrease of 12.64 percent when compared to the previous year. During the year 2024-25 the Mining sector index stood at highest with 103.45 in Mar, 2025 and in Feb, 2025 the Index was at its lowest with 89.42.

4. ELECTRICITY SECTOR

The Electricity sector index stood at 179.77 during 2024-25 with an increase of 6.60 percent when compared to the previous year. During the year 2024-25 the Electricity sector index stood at highest with 193.79 in January, 2025 and in Aug, 2024 the index was at its lowest with 162.89.

GROUP-WISE ANALYSIS UNDER MANUFACTURING SECTOR:

1. Manufacture of food products: (10)

The index of Food Products was 99.50 during 2024-25, It was registering decrease of 6.94 percent when compared to the previous year. During the year 2024-25 the group Index stood at highest with 117.98 in Feb, 2025 and in Jun, 2024 the Index was at its lowest with 86.77 .

2. Manufacture of beverages: (11)

The Index of this group was 9.07 during 2024-25, It was registering increase of 14.09 percent when compared to the previous year. During the year 2024-25 the group Index stood at highest with 13.04 Nov, 2024 and in May, 2024 the Index was at its lowest with 3.67 .

3. Manufacture of tobacco products: (12)

The Index of this group was 0.08 during 2024-25, It was registering decrease of 61.90 percent when compared to the previous year. 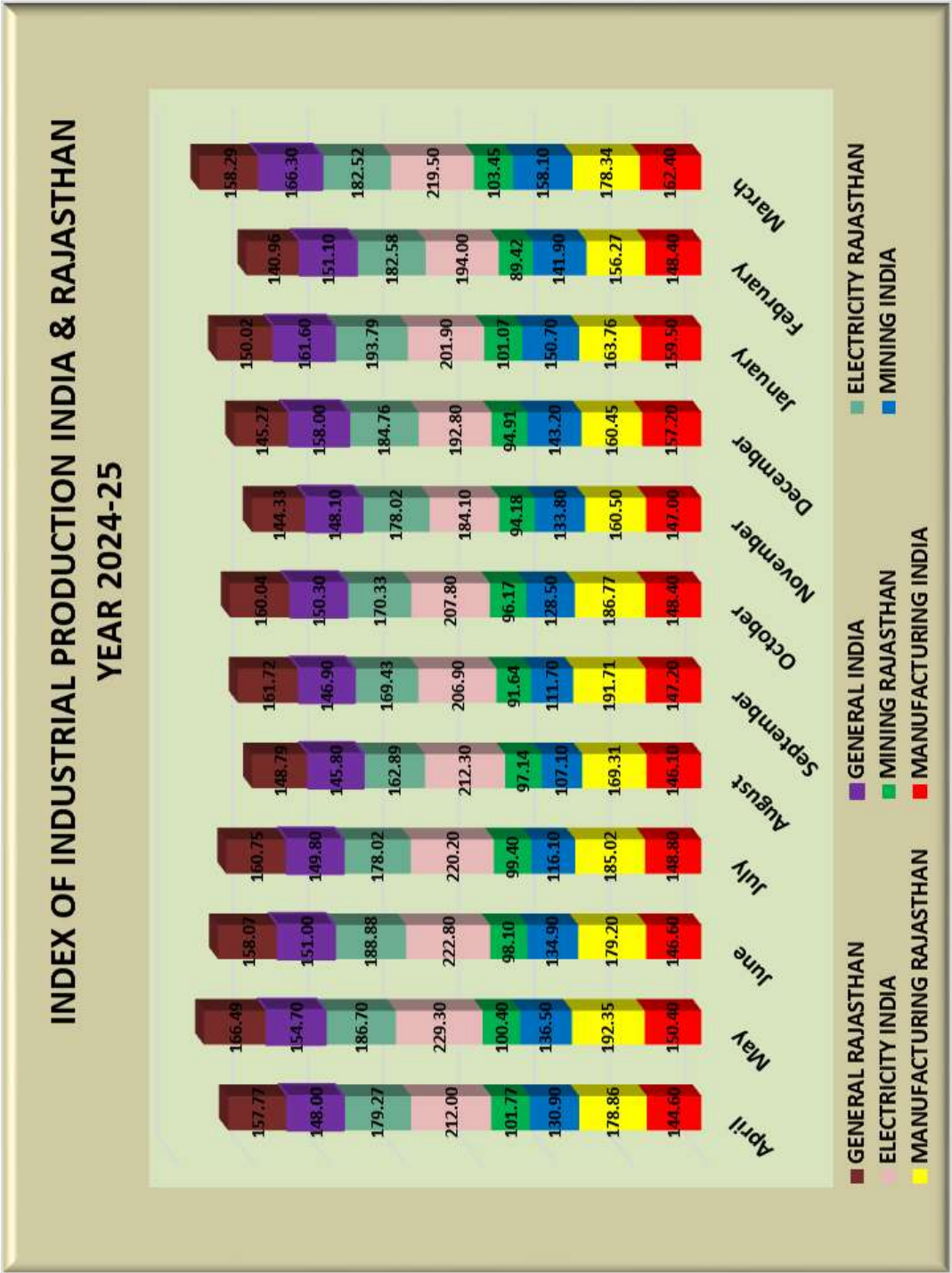

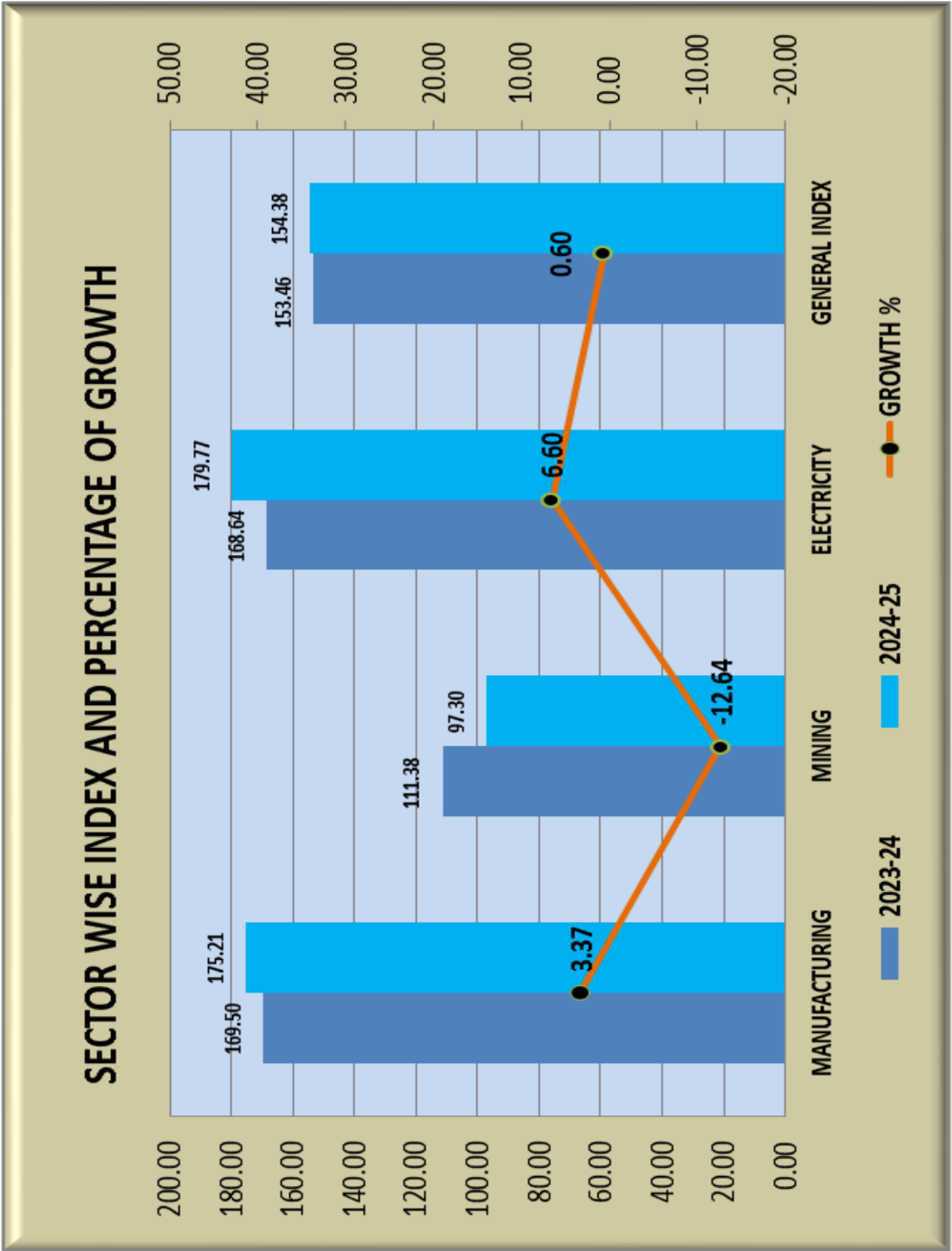

INDEX OF INDUSTRIAL PRODUCTION RAJASTHAN YEAR & SECTOR WISE



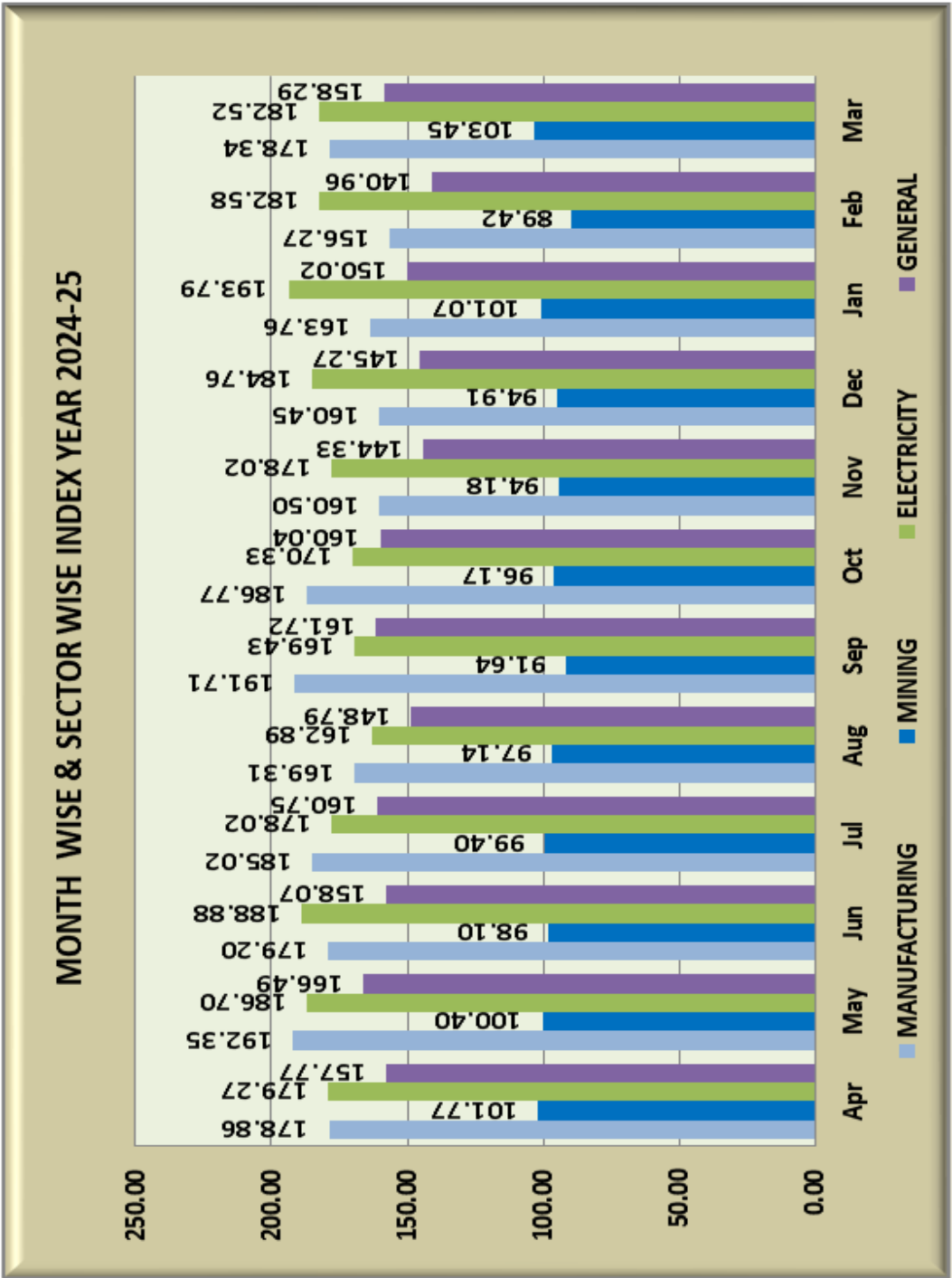
