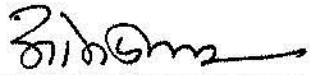

INTRODUCTION

Index of Industrial Production (IIP) is of immense use for measuring the industrial development index of a State. The index indicates relative change over the time in the volume of production in non-agricultural commodities. At the National level, the index of industrial production is being compiled by the Central Statistical Organisation, Govt. of India and is released on monthly basis. This index, however, does not serve the purpose for evaluating the industrial growth of a State. Therefore, the Directorate of Economics and Statistics has been compiling/releasing the index of industrial production for the State of Rajasthan on monthly/annual basis since 1971.

In the first series, 1970 was the base year for compiling the IIP both by the Central Statistical Organisation & Directorate of Economics and Statistics, Rajasthan. A Technical Advisory Committee (TAC) was constituted by C.S.O., Govt. of India in May, 2010 to formulate guidelines and methodology for preparation of comparable IIP of States/U.Ts. On the basis of recommendation of TAC it was decided to bring forward the base year from 1993-94 to 2004-05.

The recommendation of the Technical Advisory Committee on comparable index of Industrial Production are examined by the Central Statistical Organisation (CSO), Govt. of India and the guidelines on compilation of State level Index of Industrial Production are prepared. According to criteria laid down in the guidelines issued by Central Statistical Organisation, the Directorate of Economic and Statistical Analysis, Rajasthan selected the items basket and prepared the weighting diagram for preparation of comparable State Level Index of Industrial Production with 2004-05 as base year.

METHODOLOGY

The state level IIP covers the three major industrial sectors viz. Manufacturing, Mining & Quarrying and Electricity (Excluding Gas) as is being followed in the all India IIP. For mining and quarrying sector the production data has been supplied by the Indian Bureau of Mines, Nagpur, where as in the case of Electricity requisite data has been provide by the Central Electricity Authority, New Delhi, through C.S.O. New Delhi.

(I) SELECTION OF ITEM BASKET FOR MANUFACTURING SECTOR:

Technical Advisory Committee (TAC) has decided that all the items may be arranged in the descending order of value of output and the number of items selected in the State Item Basket should be such about 80% of value of output of State Manufacturing Sector is covered by the selected items. The selection of the items in the Item Basket was done on the basis of ASI 2004-05 (Ex-Factory Value) supplied by the C.S.O.

The Sector Level and the Item Level Weighting Diagram is based upon the value of output (Ex-Factory Value) of the registered as well as Un-registered manufacturing sector. As per C.S.O. instruction NIC 2004 has been used for preparation of weighting diagram.

(II) WEIGHTING DIAGRAM:

For the purpose of compilation of State IIP, three Major Industrial Sectors namely (i) Manufacturing (ii) Mining and Quarrying and (iii) Electricity (Excluding Gas) were considered. The proportions of value of output for these sectors were converted in to sector weights, such that their total equals 1000. The value of output figures for the manufacturing sector were taken from the ASI Detailed Results 2004-05 which were supplied by CSO where as the value of output figures for the Mining and Quarrying and Electricity sectors were supplied by IBM, Nagpur and CSO respectively.

The total weight of the manufacturing sector (Registered and Un-Registered) was apportioned among the 2-digit industry groups in proportion of their value of output available from the detailed results of ASI 2004-05.

As regards Mining and Quarrying Sector its weight was apportioned to the items included in the item basket in proportion to their value of output. Since Electricity sector is a single sector, no apportioning of weight is required.

METHOD OF CALCULATION OF IIP:

The monthly Index of Industrial Production is calculated as Weighted Arithmetic Mean of the production relatives in respect of selected items as follows:

$$I = \frac{\sum R_i \times W_i}{\sum W_i}$$

Where I is the index, R_i is the production relative of item i th and W_i is the Weight allotted to it.

The production relative (R_i) of i th item for the month has been calculated by using the following formula:

$$R_i = \frac{P_{ic}}{P_{io}} \times 100$$

Where P_{ic} = Production of i th item in the current month,

P_{io} = Production of the i th item in the base month.

Annual Index of Industrial Production is calculated as arithmetic average of monthly indices.

SOURCE OF DATA:

For preparation of the Current Series (Base Year: 2004-05) of index of Industrial Production, for Rajasthan, initially 997 industrial units have been selected for collection of production data in respect of 294 items. The base year (2004-05) production data in respect of the selected items have been supplied by C.S.O. on the basis of 2004-05 schedules made available by NSSO. The monthly data of the production for the subsequent period i.e. from 2001 onwards is being obtained directly from the Industrial Units.

The source of Mining Sector data is the Indian Bureau of Mines, Nagpur, and for the Electricity Sector generation figures furnished by the Central Electricity Authority through C.S.O.

GENERAL REVIEW:

(I) GENERAL PERFORMANCE: -The General index of Industrial Production stood at 169.77 during 2012. During the year 2012 the General Index stood at highest with 188.44 in March, 2012 and in July, 2012 the index was at its lowest with 159.89.

(II) MANUFACTURING SECTOR: -The Manufacturing sector index stood at 163.15 during 2012. During the year 2012 the Manufacturing sector Index stood at highest with 174.19 in March, 2012 and in September, 2012 the index was at its lowest with 155.47.

(III) MINING SECTOR: -The Mining sector index stood at 210.33 during 2012. During the year 2012 the Mining sector index stood at highest with 253.49 in March, 2012 and in August, 2012 the Index was at its lowest with 185.08.

(IV) ELECTRICITY SECTOR: -The Electricity sector index stood at 150.02 during 2012. During the year 2012 the Electricity sector index stood at highest with 167.39 in January, 2012 and in July, 2012 the index was at its lowest with 128.16.

GROUP-WISE ANALYSIS UNDER MANUFACTURING SECTOR:

(I) CODE NO. 15- Manufacture of food products and beverage.

The index of Food Products was 33.28 during 2012. During the year 2012 the group Index stood at highest with 53.53 in May, 2012 and in September, 2012 the Index was at its lowest with 23.19.

(II) CODE NO. 16– Manufacture of Tobacco products.

The Index of this group was 239.99 during 2012. During the year 2012 the group Index stood at highest with 310.16 in July, 2012 and in June, 2012 the Index was at its lowest with 178.35.

(III) CODE NO. 17 – Manufacture of textiles.

The Index of this group was 52.73 during 2012. During the year 2012 the group Index stood at highest with 57.24 in January, 2012 and in November, 2012 the Index was at its lowest with 48.11.

(IV) CODE NO. 18 – Manufacture of wearing apparel; dressing and dyeing of furniture: -

The Index of this group was 25.33 during 2012. During the year 2012 the group Index stood at highest with 28.86 in October, 2012 and in April, 2012 the Index was at its lowest with 21.84.

(V) CODE NO. 19 Manufacture of leather & luggage: -

The Index of this group was 10.36 during 2012. During the year 2012 the group Index stood at highest with 12.67 in May, 2012 and in August, 2012 the Index was at its lowest with 09.25.

(VI) CODE NO. 20 –Manufacture of wood & wood products: - The Index of this group was 178.18 during 2012. During the year 2012 the group Index stood at highest with 192.58 in August, 201 and in January, 2012 the Index was at its lowest with 156.30

(VII) CODE NO. 21 - Manufacture of articles of straw and plaiting materials: -

The Index of this group was 3.28 during 2012. During the year 2012 the group Index stood at highest with 4.39 in January, 2012 and in May, 2012 the Index was at its lowest with 2.61.

(VIII) CODE NO. 22 - Manufacture of paper and paper Products: -

The Index of this group was 41.43 during 2012. During the year 2012 the group Index stood at highest with 60.59 in July, 2012 and in February, 2012 the Index was at its lowest with 24.15.

(IX) CODE NO. 23 - Manufacture of coke, refined petroleum Products:

The Index of this group was 27.44 during the year 2012. During the year 2012 the group Index stood at highest with 31.92 in April, 2012 and in March, 2012 the Index was at its lowest with 22.49.

(X) CODE NO. 24 - Manufacture of chemical and chemical Products:

The Index of this group was 68.30 during 2012. During the year 2012 the group Index stood at highest with 73.38 in July, 2012 and in November, 2012 the Index was at its lowest with 61.99.

(XI) CODE NO. 25 - Manufacture of rubber and plastic products:-

The Index of this group was 101.44 during 2012. During the year 2012 the group Index stood at highest with 112.63 in May, 2012 and in August, 2012 the Index was at its lowest with 94.18.

(XII) CODE NO. 26 - Manufacture of other non-metallic minerals products: -

The Index of this group was 354.93 during 2012. During the year 2012 the group Index stood at highest with 384.92 in March, 2012 and in July, 2012 the Index was at its lowest with 334.17.

(XIII) CODE NO. 27 - Manufacture of basic metals:

The Index of this group was 186.43 during 2012. During the year 2012 the group Index stood at highest with 201.58 in June, 2012 and in October, 2012 the Index was at its lowest with 164.52

(XIV) CODE NO. 28 – Manufacture fabricated metal products, except machinery and equipment's: -

The Index of this group was 2523.02 during 2012. During the year 2012 the group Index stood at highest with 2860.98 in August, 2012 and in April, 2012 the Index was at its lowest with 2132.48

(XV) CODE NO. 29 Manufacture of machinery and equipment's. N.E.C: -

The Index of this group was 24.69 during 2012. During the year 2012 the group Index stood at highest with 30.52 in June 2012 and in January, 2012 the Index was at its lowest with 17.76.

(XVI) CODE NO. 30 – Manufacture office accounting and computing machinery: -

The Index of this group was 0.00 during 2012 .

(XVII) CODE NO. 31 – Manufacture of electrical machinery and apparatus N.E.C:-

The Index of this group was 10.39 during 2012 .During the year 2012 the group Index stood at highest with 15.00 in May, 2013 and in October, 2012 the Index was at its lowest with 7.56.

(XVIII) CODE NO. 32 – Radio, T.V. and communication equipment's & parts: -

The Index of this group was 0.44 during 2012. During the year 2012 the group Index stood at highest with 0.93 in September, 2012 and in March, 2012 the Index was at its lowest with 0.17.

(XIX) CODE NO. 33 – Medical, Precision and optical instruments, watch & clock: -

The Index of this group was 24.36 during 2012. During the year 2012 the group Index stood at highest with 38.36 in April, 2012 and in August, 2012 the Index was at its lowest with 15.87.

(XX) CODE NO. 34 – Manufacture of motor vehicle, Trailers & semi-trailers: -

The Index of this group was 54.05 during 2012. During the year 2012 the group Index stood at highest with 85.99 in January, 2012 and in September, 2012 the Index was at its lowest with 41.02.

(XXI) CODE NO. 35 – Manufacture of other transport equipment's:

The Index of this group was 89.93 during 2012. During the year 2012 the group Index stood at highest with 99.42 in April, 2012 and in September 2012 the Index was at its lowest with 82.36.

(XXII) CODE NO.36 – Manufacture of furniture, ManufacturingN.E.C: -

The Index of this group was 31.04 during 2012. During the year 2012 the group Index stood at highest with 42.15 in December, 2012 and in February, 2012 the Index was at its lowest with 15.99.

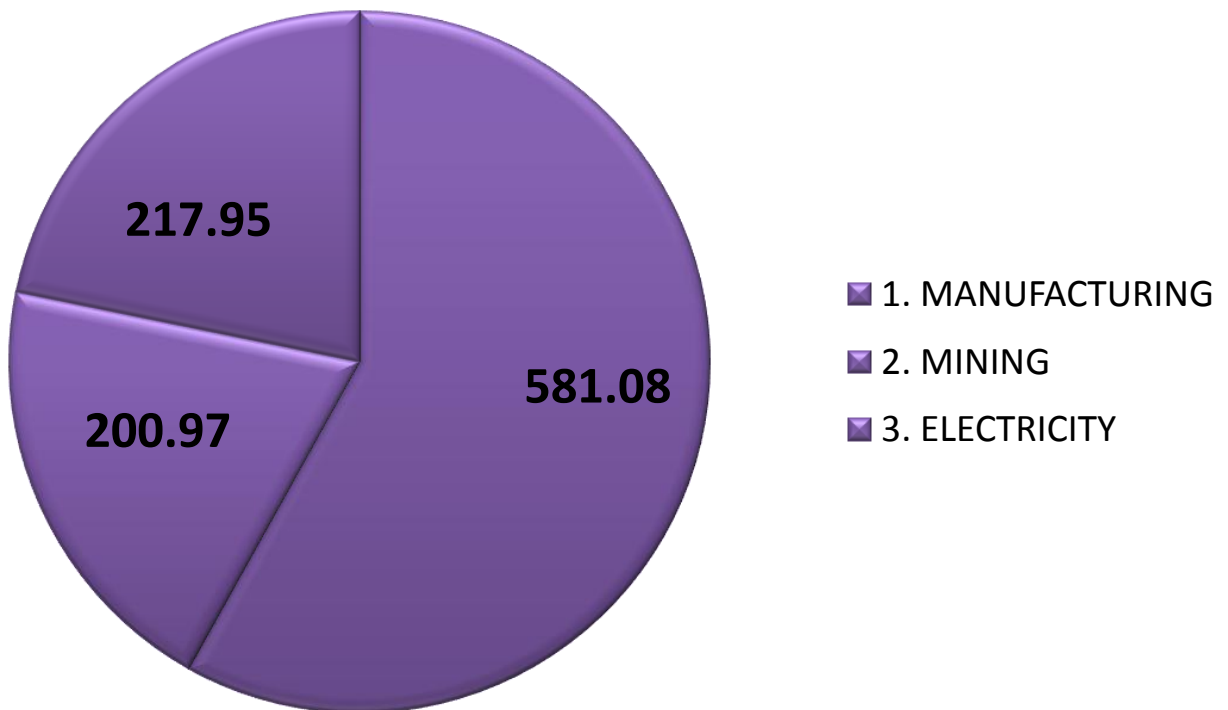

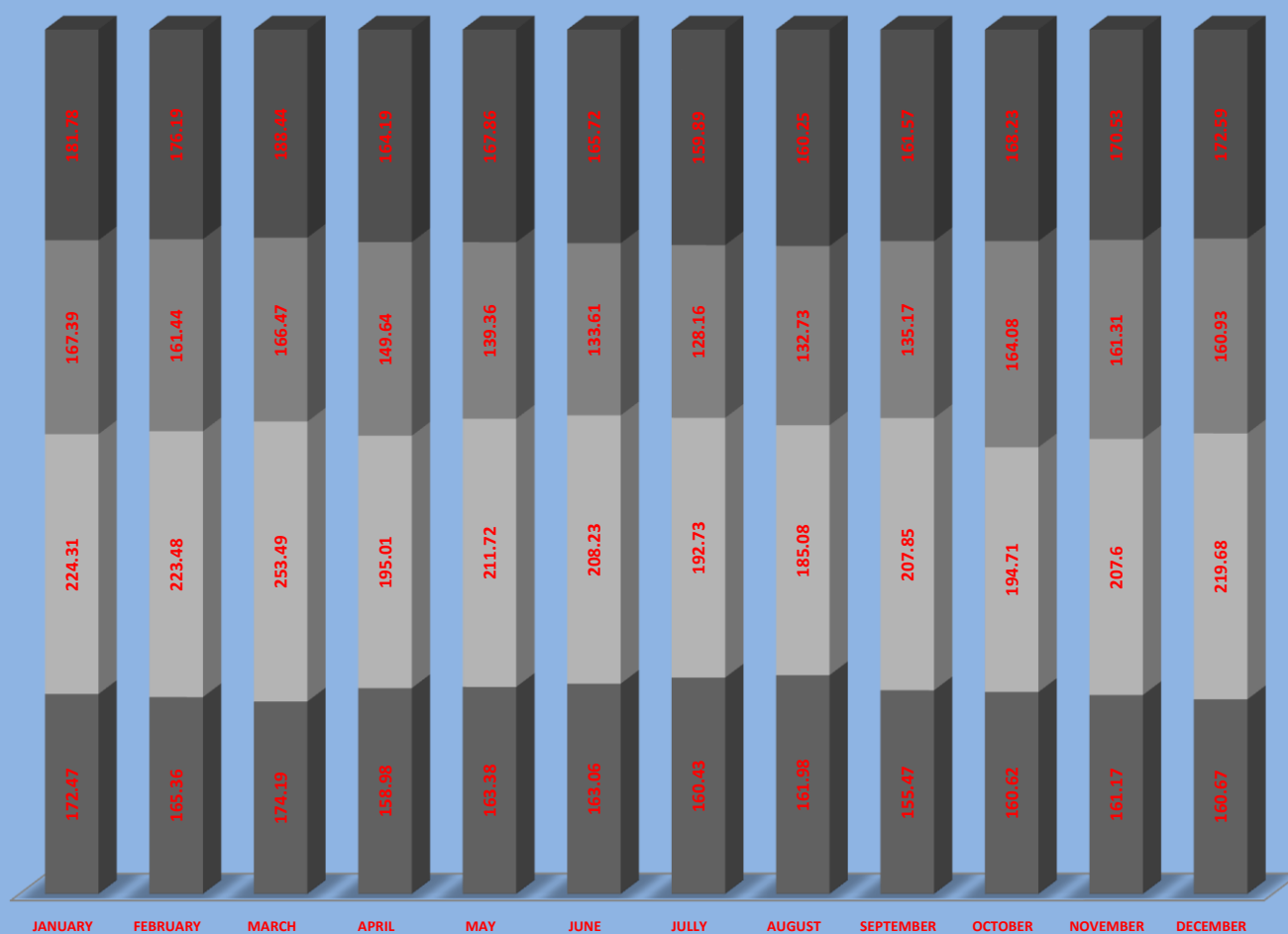
