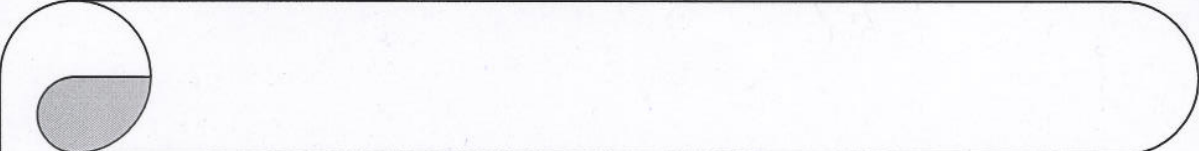

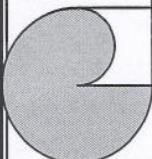

I hope this publication would be found useful for Planners, Policy Makers, Research Scholars and Others interested in industrial development in the State.

I am grateful to the management of all concerned factories who extended their cooperation in providing data.

Suggestions, if any, for the improvement of coverage of the report will be appreciated.

INTRODUCTION

Index of Industrial Production (IIP) is of immense use for measuring the industrial development index of a State. The index indicates relative change over the time in the volume of production in non-agricultural commodities. At the National level, the index of industrial production is being compiled by the Central Statistical Organization, Govt. of India and is released on monthly basis. This index, however, does not serve the purpose for evaluating the industrial growth of a State. Therefore, the Directorate of Economics and Statistics has been compiling/releasing the index of industrial production for the State of Rajasthan on monthly/annual basis since 1971.

In the first series, 1970 was the base year for compiling the IIP both by the Central Statistical Organization & Directorate of Economics and Statistics, Rajasthan. A Technical Advisory Committee (TAC) was constituted by C.S.O., Govt. of India in June, 1995 to formulate guidelines and methodology for preparation of comparable IIP of States/U.Ts. On the basis of recommendation of TAC it was decided to bring forward the base year from 1970 to 1993-94. The terms of reference of the TAC on IIP were modified in November, 1996 to include the revision of the all India IIP as well.

METHODOLOGY

The state level IIP covers the three major industrial sectors viz Manufacturing, Mining & Quarrying and Electricity (Excluding Gas) as is being followed in the all India IIP. For mining and quarrying sector the production data has been supplied by the Indian Bureau of Mines, Nagpur, Whereas in the case of Electricity requisite data has been provide by the Central Electricity Authority, New Delhi, through C.S.O. New Delhi.

(I) SELECTION OF ITEM BASKET FOR MANUFACTURING SECTOR:

Technical Advisory Committee (TAC) has decided that all the items may be arranged in the descending order of value of output and the number of items selected in the State Item Basket should be such that about 80% of value of output of State Manufacturing Sector is covered by the selected items. The selection of the items in the Item Basket was done on the basis of ASI 1993-94 (Ex-Factory Value) supplied by the C.S.O.

The Sector Level and the Item Level Weighting Diagram is based upon the value of output (Ex-Factory Value) of the registered as well as Un-registered manufacturing sector. As per C.S.O. instruction NIC 1987 has been used for preparation of weighting diagram.

(II) WEIGHTING DIAGRAM:

For the purpose of compilation of State IIP, three Major Industrial Sectors namely (i) Manufacturing (ii) Mining and Quarrying and (iii) Electricity (Excluding Gas) were considered. The proportions of value of output for these sectors were converted in to sectoral weights, such that their total equals 1000. The value of output figures for the manufacturing sector were taken from the ASI Detailed Results 1993-94 which were supplied by CSO where as the value of output figures for the Mining and Quarrying and Electricity sectors were supplied by IBM, Nagpur and CSO respectively.

The total weight of the manufacturing sector (Registered and Un-Registered) was apportioned among the 2-digit industry groups in proportion of their value of output available from the detailed results of ASI 1993-94.

As regards Mining and Quarrying Sector its weight was apportioned to the items included in the item basket in proportion to their value of output. Since Electricity sector is a single sector, no apportioning of weight is required.

METHOD OF CALCULATION OF IIP:

The monthly Index of Industrial Production is calculated as Weighted Arithmetic Mean of the production relatives in respect of selected items as follows:

$$I = \frac{\sum R_i \times W_i}{\sum W_i}$$

Where I is the index, R_i is the production relative of item i th and W_i is the weight allotted to it.

The production relative (R_i) of i th item for the month has been calculated by using the following formula:

$$R_i = \frac{P_{ic}}{P_{io}} \times 100$$

Where P_{ic} = Production of i th item in the current month,

P_{io} = Production of the i th item in the base month.

Annual Index of Industrial Production is calculated as arithmetic average of monthly indices.

SOURCE OF DATA:

For preparation of the Current Series (Base Year: 1993-94) of index of Industrial Production, for Rajasthan, initially 369 industrial units have been selected for collection of production data in respect of 138 items. The base year (1993-94) production data in respect of the selected items have been supplied by C.S.O. on the basis of 1993-94 schedules made available by NSSO. The monthly data of the production for the subsequent period i.e. from 2001 onwards is being obtained directly from the Industrial Units.

The source of Mining Sector data is the Indian Bureau of Mines, Nagpur, and for the Electricity Sector generation figures furnished by the Central Electricity Authority through C.S.O.

GENERAL REVIEW:

(I) GENERAL PERFORMANCE :- The General index of Industrial Production stood at 319.61 during 2009 as against 282.95 in 2008 there by registering a positive growth of 12.96 percent. During the year 2009 the General Index stood at highest with 406.47 in August, 2009 and in November, 2009 the index was at its lowest with 198.22.

(II) MANUFACTURING SECTOR: - The Manufacturing sector index stood at 322.97 during 2009 with an increase of 14.20 percent when compared to the previous year. During the year 2009 the Manufacturing sector Index stood at highest with 423.20 in August, 2009 and in November, 2009 the index was at its lowest with 183.40

(III) MINING SECTOR: - The Mining sector index stood at 288.61 during 2009 with an increase of 6.79 percent when compared to the previous year. During the year 2009 the Mining sector index stood at highest with 317.93 in June ,2009 and in August,2009 the Index was at its lowest with 273.49.

(IV) ELECTRICITY SECTOR: - The Electricity sector index stood at 292.60 during 2009 with an increase of 0.63 percent when compared to the previous year. During the year 2009 the Electricity sector index stood at highest with 370.63 in December ,2009 and in July,2009 the index was at its lowest with 256.96.

GROUP-WISE ANALYSIS UNDER MANUFACTURING SECTOR:

(1) CODE NO. 20-21 Manufacturing of Food Products:- The index of Food Products was 53.54 during 2009 registering an decrease of 56.51 percent when compared to the previous year. During the year 2009 the group Index stood at highest with 70.77 in November,2009 and in August,09the Index was at its lowest with 37.98

(1I) CODE NO. 22 Manufacturing of Beverages, Tobacco and Tobacco Products: - The Index of this group was 655.52 during 2009 It was registering a decrease of 3.52 percent when compared to the previous year. During the year 2009 the group Index stood at highest with 710.19 in April 09 and in August,2009 the Index was at its lowest with 565.61.

(1II) CODE NO. 23 Manufacturing of Cotton Textiles: - The Index of this group was 39.62 during 2009 It was registering an decrease of 37.94 percent when compared to the previous year. During the year 2009 the group Index stood at highest with 329.79 in January,09 and in August, 2009 the Index was at its lowest with 5.88.

(IV) CODE NO. 24 Manufacturing of Wool, Silk and Synthetic Fiber Textiles: - The Index of this group was 150.56 during 2009 registering a Increase of 34.39 percent when compared to the previous year. During the year 2009 the group Index stood at highest with 166.46 in December,2009 and in July 2009 the Index was at its lowest with 132.69.

- (V) CODE NO. 26 Manufacturing of Textile Products (other than mills):-** The Index of this group was 19.42 during 2009 It was decreased by 21.85 percent when compared to the previous year. During the year 2009 the group Index stood at highest with 25.79 in December,2009 and in August,2009 the Index was at its lowest with 11.70
- (VI) CODE NO. 27 Manufacturing of Wood and Wood Products: -** The Index of this group was 101.90 during 2009 It was decreased by 8.27 percent when compared to the previous year. During the year 2009 the group Index stood at highest with 123.24 in October,2009 and in May,2009 the Index was at its lowest with 76.30.
- (VII) CODE NO. 28 of Paper and Paper Products, Printing, Publishing and Allied Industries: -** The Index of this group was 10020.55 during 2009 It was decreased by 02.58 percent when compared to the previous year. During the year 2009 the group Index stood at highest with 13276.69 in July,09 and in January,2009 the Index was at its lowest with 3786.85.
- (VIII) CODE NO. 29 Manufacturing of Leather Products: -** The Index of this group was 161.88 during 2009 registering decrease of 4.91 percent when compared to the previous year. During the year 2009 the group Index stood at highest with 207.94 in September,2009 and in May,2009 the Index was at its lowest with 110.34.
- (IX) CODE NO. 30 Manufacturing of Basic Chemical and Chemical Products: -** The Index of this group was 82.58 during 2009 registering decrease of 30.92 percent when compared to the previous year. During the year 2009 the group Index stood at highest with 133.60 in March,2009 and in November ,2009 the Index was at its lowest with 45.78
- (X) CODE NO. 31 Manufacturing of Rubber, Plastic, Petroleum and Coal Products: -** The Index of this group was 13.45 during the year 2009 registering an decrease of 64.46 percent when compared to the previous year. During the year 2009 the group Index stood at highest with 38.44 in January,2009 and in August,2009 the index was at its lowest with 3.65..

(XI) CODE NO. 32 Manufacturing of Non Metallic Mineral

Products: - The Index of this group was 131.59 during 2009 registering Increase of 12.86 percent when compared to the previous year. During the year 2009 the group Index stood at highest with 146.27 in March 09 and in September,2009 the Index was at its lowest with 119.37.

(XII) CODE NO. 33 Manufacturing of Basic Metal and Alloy

Industries: - The Index of this group was 144.71 during 2009 registering Decrease of 12.07 percent when compared to the previous year. During the year 2009 the group Index stood at highest with 175.91 in December,2009 and in February,2009 the Index was at its lowest with 114.50.

(XIII) CODE NO. 34 Manufacturing of Metal Products and

Parts except Machinery & Equipment: - The Index of this group was 62.05 during 2009. It was increased by 1.72 percent when compared to the previous year. During the year 2009 the group Index stood at highest with 86.33 in December,2009 and in May ,2009 the Index was at its lowest with 17.50.

(XIV) CODE NO. 35-36 Manufacturing of Machinery

Equipment other than Transport Equipment: - The Index of this group was 1354.18 during 2009 It was increased by 245.85 percent when compared to the previous year. During the year 2009 the group Index stood at highest with 2496.36 in June,2009 and in November,2009 the Index was at its lowest with 150.79.

(XV) CODE NO. 37 Manufacturing of Transport Equipment

Parts: - The Index of this group was 4194.10 during 2009 registering decrease of 14.26 percent when compared to the previous year. During the year 2009 the group Index stood at highest with 5736.60 in July,2009 and in December,09 the Index was at its lowest with 510.90...

(XVI) CODE NO. 38 Other Manufacturing Industries: - The

Index of this group was 248.71 during 2009 registering an increase of 3.89 percent when compared to the previous year. During the year 2009 the group Index stood at highest with 545.02 in September,2009 and in July,2009 the Index was at its lowest with 97.67.

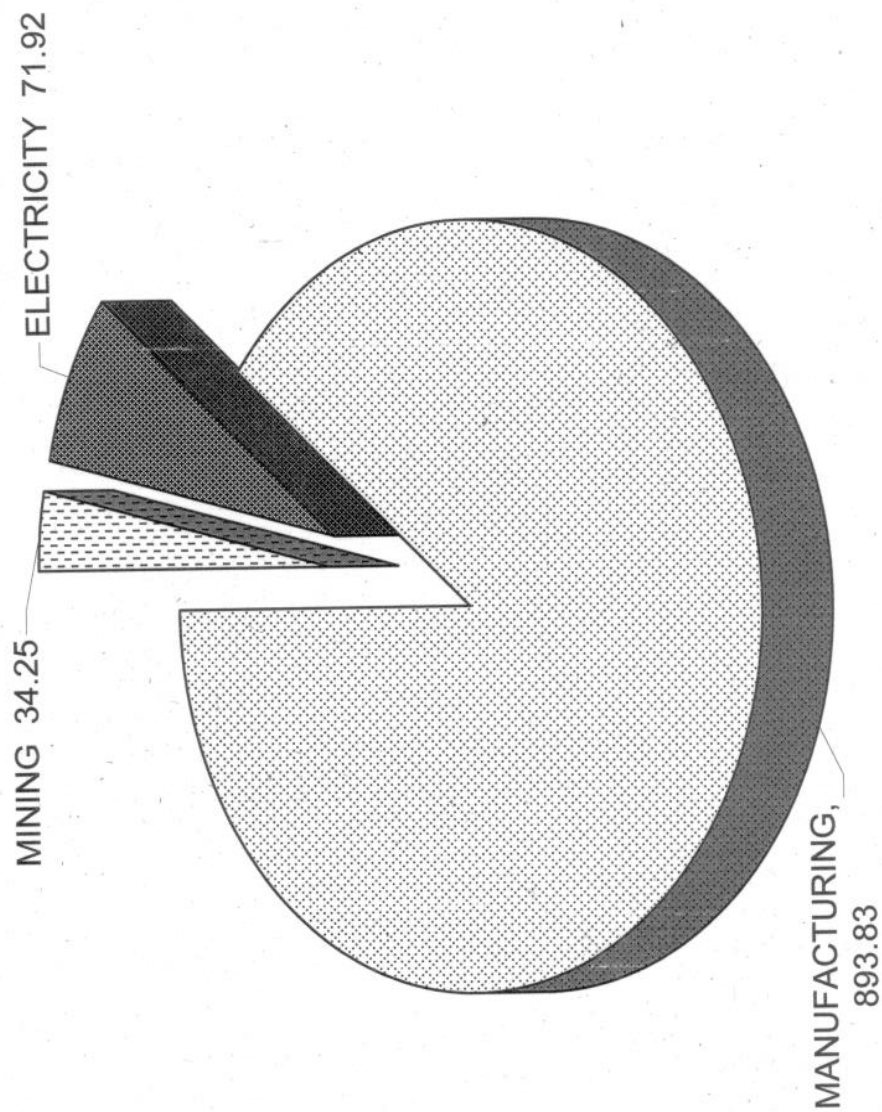

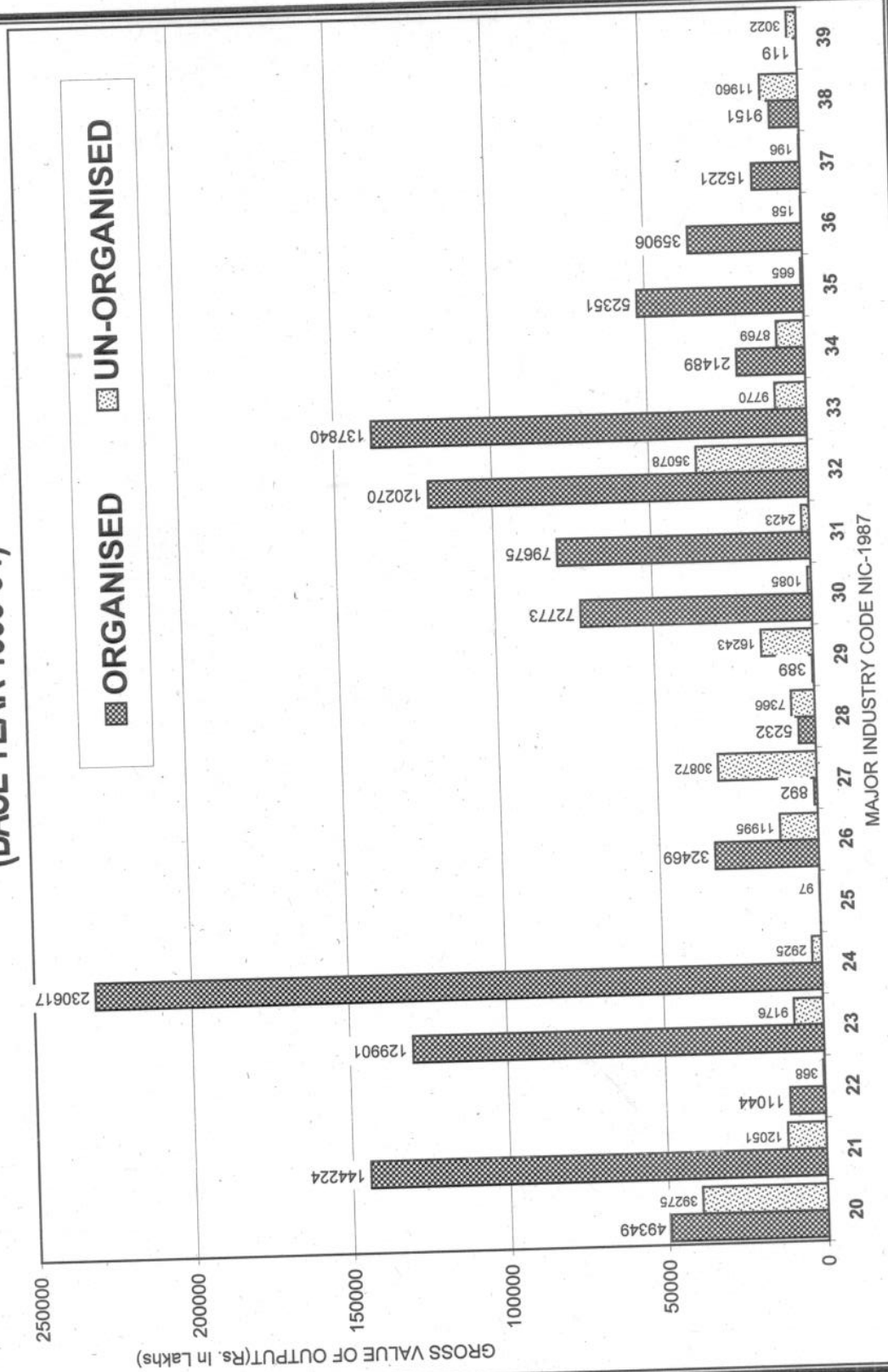
INDEX OF INDUSTRIAL PRODUCTION 2009- RAJASTHAN

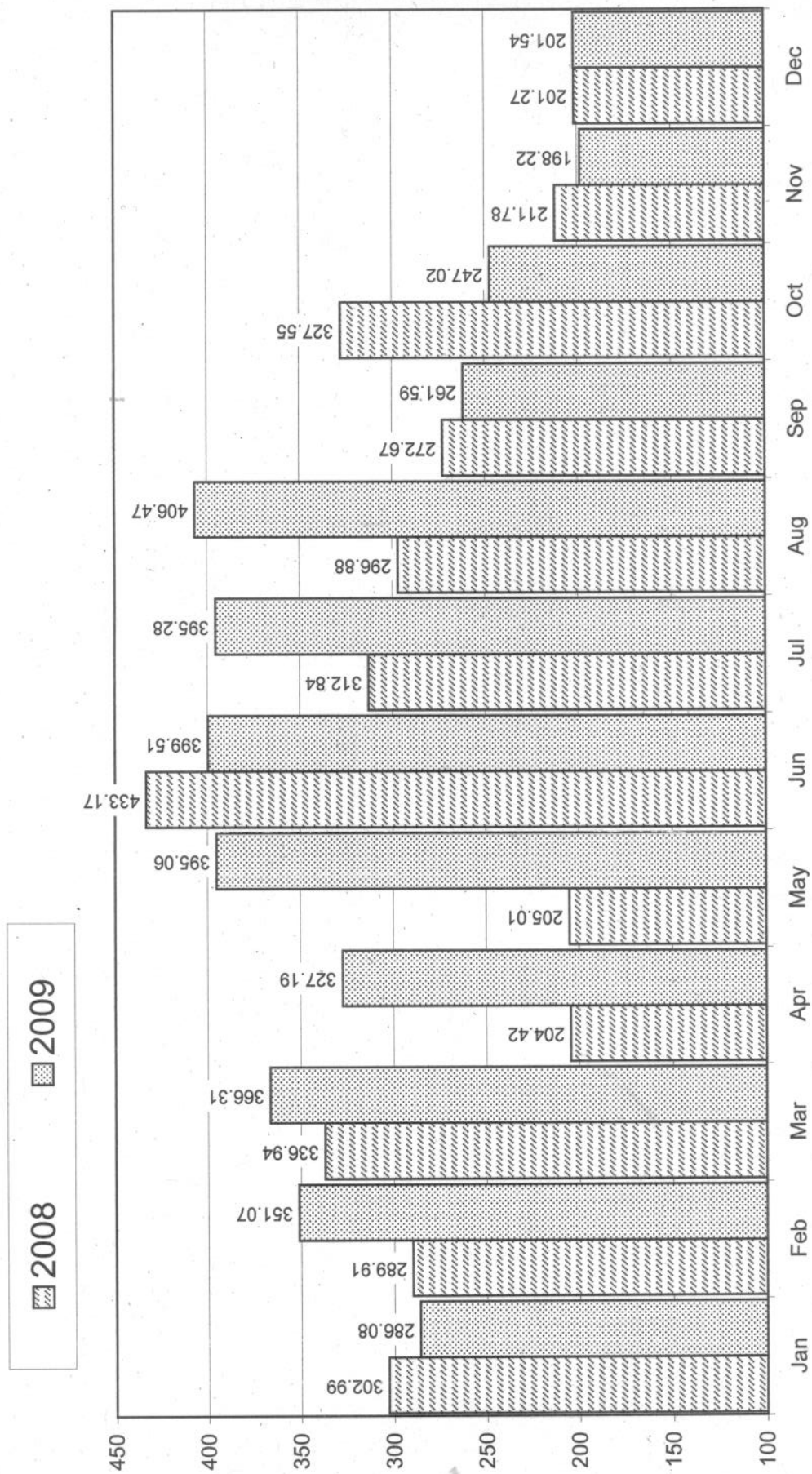

INDEX OF INDUSTRIAL PRODUCTION RAJASTHAN MONTH & YEAR WISE GENERAL INDEX

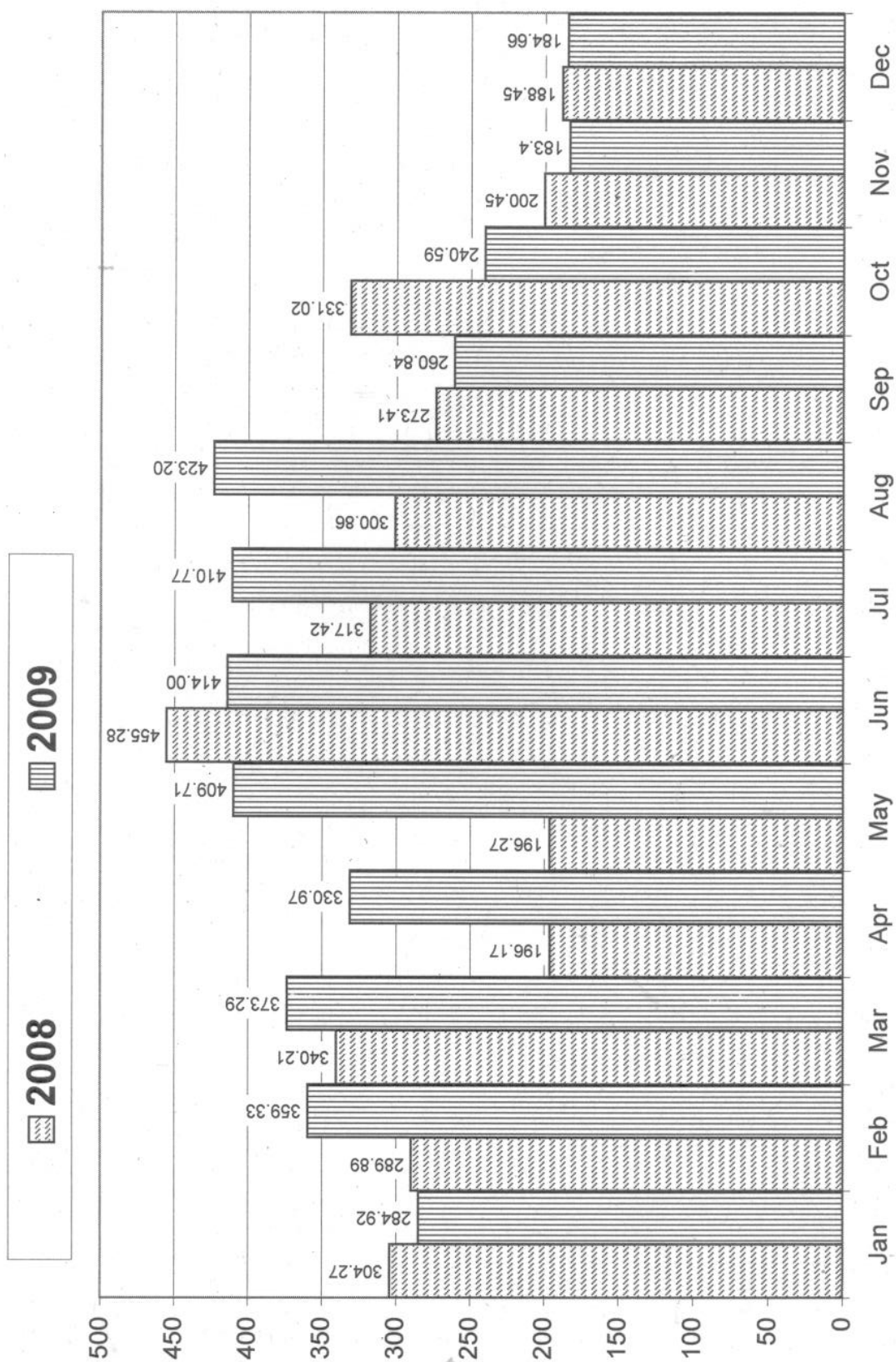

MONTH & YEAR WISE INDEX OF MANUFACTURING SECTOR



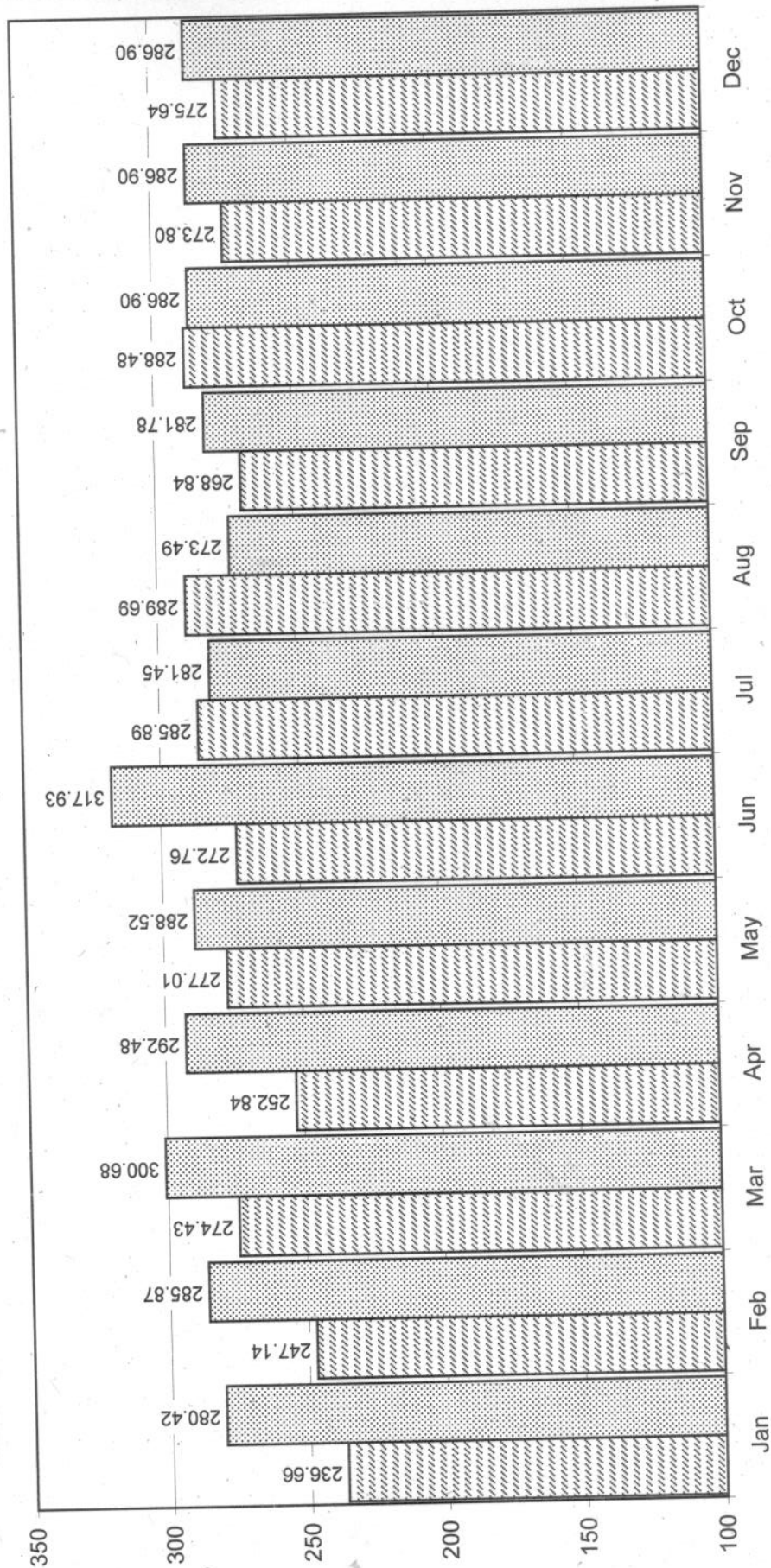

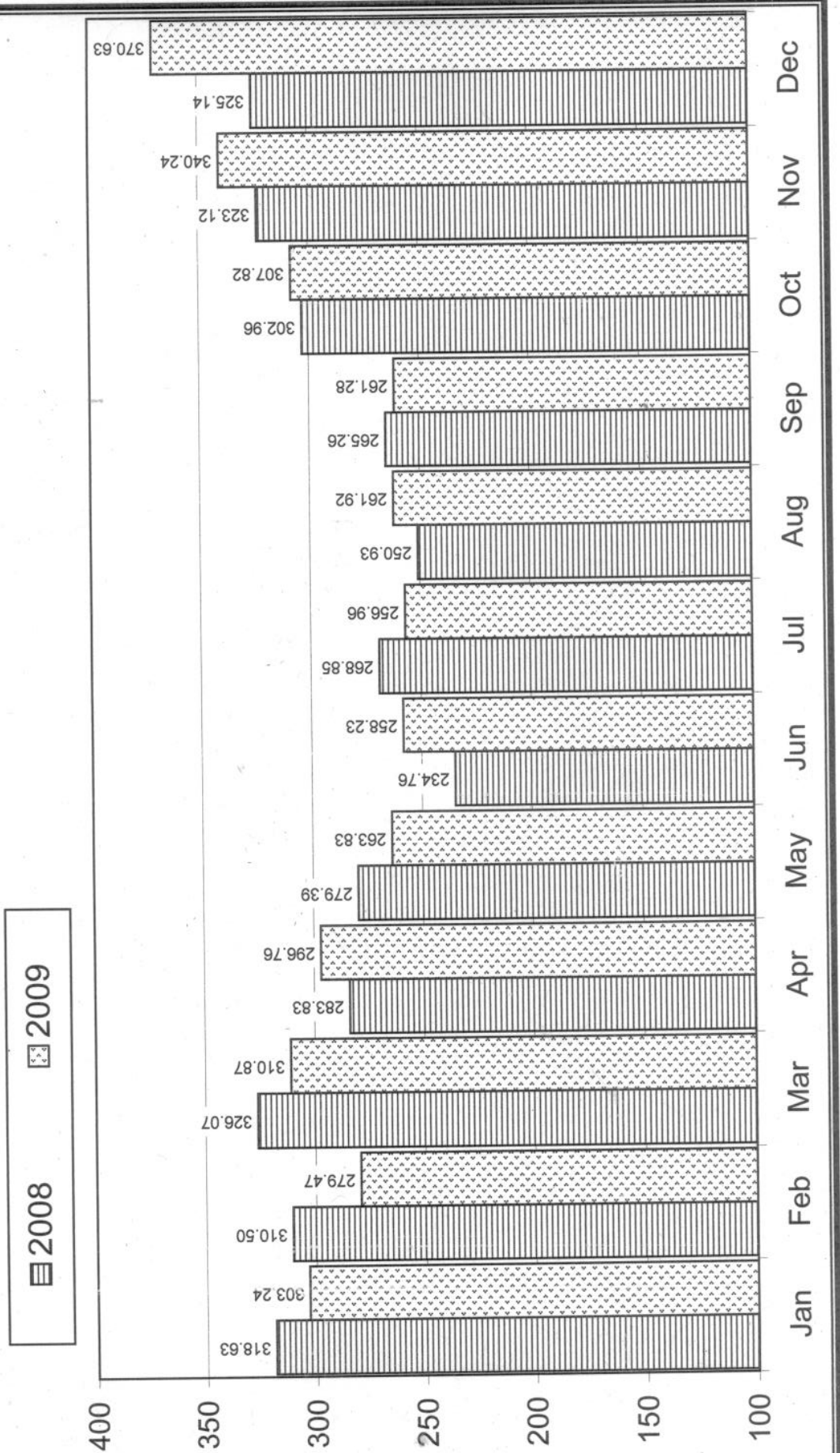
